THE DENTAL CENTER PROVIDES ROUTINE AND EMERGENCY DENTAL SERVICES FOR CHILDREN FROM LOW INCOME FAMILIES THAT OTHERWISE ARE UNABLE TO OBTAIN PROPER DENTAL CARE. APPROXIMATELY 200 STUDENTS ARE TREATED EACH YEAR WITH AN AVERAGE OF OVER 1,200 TREATMENTS THROUGH MULTIPLE APPOINTMENTS. SERVICES ALSO INCLUDE PREVENTATIVE DENTAL CARE, EDUCATION, FLUORIDE TREATMENTS, ROOT CANALS AND CROWNS. CHILDREN ARE REFERRED FOR CARE FROM SCHOOL SYSTEMS AND OTHER COMMUNITY ORGANIZATIONS IN THE POMONA VALLEY COMMUNITIES. THE DENTAL CENTER INCLUDES TWO FULLY EQUIPPED TREATMENT AREAS AND IS STAFFED WITH A BILINGUAL DENTIST, DENTAL ASSISTANT AND AN OFFICE MANAGER/RECEPTIONIST.
