APPROXIMATELY 200 STUDENTS ARE TREATED EACH YEAR WITH AN AVERAGE OF OVER 1,200 TREATMENTS THROUGH MULTIPLE APPOINTMENTS. SERVICES ALSO INCLUDE PREVENTATIVE DENTAL CARE, EDUCATION, FLUORIDE TREATMENTS, ROOT CANALS AND CROWNS.
