OVER 200 STUDENTS AND FAMILY MEMBERS ARE TREATED EACH YEAR WITH AN AVERAGE OF OVER 1,200 TREATMENTS THROUGH MULTIPLE APPOINTMENTS. SERVICES ALSO INCLUDE PREVENTATIVE DENTAL CARE, EDUCATION, FLUORIDE TREATMENTS, ROOT CANALS AND CROWNS.
